





Lifetime Membership

Girl Scouts is the preeminent organization dedicated to helping all girls develop the confidence, determination, and skills needed to thrive in today's world. As a lifetime member of Girl Scouts of the USA, you will join a growing number of adults who believe in and support the ideals and principles of Girl Scouting. In partnership with other dedicated adults, you will have the opportunity as a volunteer to assist directly or indirectly in developing qualities that will serve girls throughout their lives and help them realize their full potential. When you become a lifetime member, you show a commitment to all girls—among them, many of the leaders of tomorrow— in our diverse population.

What are the benefits of lifetime membership?

Through lifetime membership in Girl Scouts, you will have the opportunity to belong to, and support, the largest voluntary organization for girls and women in the world. You will also receive:

• a lifetime membership card and certificate.

Who is eligible to become a lifetime member?

Lifetime membership as a Girl Scout adult is available to any individual who:

- accepts the principles and beliefs of the Girl Scout Movement.
- pays the one-time lifetime membership dues.
- is 18 years of age or older or has a high school diploma or the equivalent.

The lifetime membership dues are \$300 (25 times the annual dues). A special lifetime membership, at the reduced cost of \$156, is offered to girls who are registered Senior Girl Scouts at the time of their high school graduation, provided they apply for lifetime membership before their current annual membership expires.

As a lifetime member, you may purchase the Lifetime Membership Pin.



Where does the money go?

Lifetime membership dues are placed in a membership endowment fund that is used to support, develop, and extend Girl Scout membership to all girls.

How do I become a lifetime member?

Please return the completed form, along with your check, money order, or credit card information, to your local Girl Scout council office or to Girl Scouts of the USA, 420 Fifth Avenue, New York, NY 10018-2798. All checks and money orders that are mailed to your local Girl Scout council should be made payable to the council. Those mailed to Girl Scouts of the USA should be made payable to GSUSA.

If you are a Senior Girl Scout registering at the reduced cost, please send your lifetime registration to your local council office and note your graduation month and year on the form.
